### **ANALISIS YURIDIS TENTANG PENERBITAN SURAT KETERANGAN CATATAN KEPOLISIAN (SKCK) ONLINE TERHADAP MANTAN NARAPIDANA**

SKCK adalah Surat yang diterbitkan oleh instansi Polri melalui unit Intelejen Keamanan yang mencantumkan pernah atau tidaknya pemohon / warga masyarakat terlibat tindak pidana. Permasalahan dalam tesis ini adalah bagaimana pengaturan hukum penerbitan surat keterangan catatan kepolisian (SKCK) *online* terhadap mantan narapidana, bagaimana akibat hukum penerbitan SKCK terhadap mantan narapidana, bagaimana hambatan dan upaya dalam penerbitan surat keterangan catatan kepolisian (SKCK) *online* terhadap mantan narapidana

Penelitian yang dilakukan adalah penelitian normatif dan didukung dengan data yuridis empiris yaitu melakukan wawancara dengan Kasat Intelkam .

Pengaturan hukum penerbitan surat keterangan catatan kepolisian (SKCK) *online* terhadap mantan narapidana diatur dalam Peraturan Kapolri Nomor 6 Tahun 2023 Tentang Penerbitan Surat Keterangan Catatan Kepolisian. Para narapidana yang pernah masuk penjara masih bisa mendapatkan surat keterangan catatan kepolisian (SKCK) yang akan dimuat berbagai catatan atau riwayat pidana yang telah dilakukannya. . Akibat hukum penerbitan SKCK terhadap mantan narapidana adalah bahwa institusi Polri sudah berusaha memperbaiki pelayanan yang diberikan bahwasanya mantan narapidana juga dapat memiliki SKCK seperti halnya masyarakat yang tidak pernah terlibat tindak pidana.

Berdasarkan hasil penelitian dipahami hambatan dalam penerbitan surat keterangan catatan kepolisian (SKCK) *online* terhadap mantan narapidana adalah tidak ada petugas khusus dan pembagian tugas khusus perihal SKCK *online*. Upaya menghadapi perubahan ditunjukkan dengan perkembangan teknologi yang ada di Sentra Pelayanan SKCK dan menampung semua saran masukan yang diberikan, namun bagi anggotanya saat ini belum dapat mengatasi permasalahan terkait jaringan dan sistem SKCK *Online* yang eror.

## **ABSTRACT**

### **JURIDICAL ANALYSIS OF THE ISSUANCE OF CERTIFICATION LETTER ONLINE POLICE NOTES (SKCK) AGAINST EX-CONVICT**

*SKCK is a letter issued by the National Police agency through the Security Intelligence unit which states whether or not the applicant/member of the public has ever been involved in a criminal act. The problems in this thesis are what are the legal regulations for issuing online police record certificates (SKCK) to ex-convicts, what are the legal consequences of issuing SKCK to ex-convicts, what are the obstacles and efforts in issuing online police record certificates (SKCK) to ex-convicts?*

*The research carried out is normative research and is supported by empirical juridical data, namely conducting interviews with the Head of the Intelligence and Security Unit of the Asahan Police.*

*The legal regulations for the issuance of online police record certificates (SKCK) to former convicts are regulated in National Police Chief Regulation Number 6 of 2023 concerning the Issuance of Police Record Certificates. Prisoners who have been to prison can still get a police record certificate (SKCK) which will contain various records or criminal histories they have committed. . The legal consequence of issuing SKCKs to former convicts is that the National Police institution has tried to improve the services provided so that former convicts can also have SKCKs like people who have never been involved in criminal acts.*

*Based on the research results, it is understood that the obstacle in issuing online police record certificates (SKCK) to former convicts is that there are no special officers and a special division of tasks regarding online SKCK. Efforts to deal with change are demonstrated by the development of technology at the Asahan Police SKCK Service Center and accommodating all input suggestions given, however, its members are currently unable to overcome problems related to the SKCK Online network and system errors.*
